Marmara Campus 2026 - 2027 School Fees Information

The Istanbul International Community School is a non-profit school.

Operational costs are covered by school fees and the remaining revenue is re-invested into our school to foster a cycle of continuous improvement.

School Fees for Individuals - Applicable for those families who receive no assistance from an employer to pay or defray the cost of educating their children.

1. APPLICATION FEE — New Students Only — Due at application

one time charge

The Application Fee supports the administration of the application process, including the development and maintenance of admissions systems.

\$300*

This ensures a high standard of service while being fair and consistent to all our applicants. As such, applications will only be processed upon receipt of the application fee.

2. REGISTRATION FEE — New Students Only — Due after acceptance

one time charge

The Registration Fee is required to be paid once an application has been fully submitted and approved by the academic principals.

3. CAPITAL LEVY FEE — Newly enrolling students in Grade 1 and above — Due by 15 July 2026 Re-enrolling Grade 1 students.

one time charge

The fee is charged for newly enrolled students entering Grade 1 or above. There is no capital levy fee for students in the Early Years Program (EY3 to EY5).

\$8.000*

Re-enrolling students will pay the Capital Levy when they enroll in Grade 1.

The Capital Levy Fee allows the school to make investments in learning resources, technology and physical infrastructure that fall outside the scope of its annual operating budget.

4. TUITION FEE — Applicable to Both New and Returning Students

I. FULL PAYMENT DISCOUNT OPTION

Full Payment Discount: Families benefit from a **2.5% discount** if the tuition fee is paid in **FULL** by **15 April, 2026**.

Payments will only be accepted in USD. Transfers are subject to a bank charge, which may be deducted by your bank. Please ensure that the full USD amount of all fees is transferred to the IICS bank account. The remitter will be responsible for any shortfall resulting from currency exchange discrepancies or bank charges.

Families will receive invoices for the tuition on a monthly basis between September 2026 and June 2027. Families will receive an invoice for the capital levy in August 2026. All invoices are issued in the name of the student and sent via e-mail to parents.

***VAT included:** VAT on school fees for the 2026-27 school year is assessed at 10%. However, fees are subject to change due to potential government-imposed adjustments during the year, including VAT or other applicable taxes.

SCHOOL FEES DO INCLUDE

- Educational Materials and Innovative Learning Resources, including textbooks, classroom materials, digital platforms, and interactive technologies, school owned iPads for EY3-Grade 4, MacBooks for Grade 5 that support engaging, future-focused learning experiences
- Catering Services for students, staff and school events
- Overnight Multi-Day Class Trips for Grades 4–12 (including transportation, accommodation, admission fees and activities)
- Field Trips within Istanbul for all grades (including transport, meals, and admission fees)
- A wide range of Primary Co-Curricular Activities (CCAs)
- Secondary Athletics and Activities, including participation in local and international tournaments, an opportunity that distinguishes IICS from other schools in Turkey
- Yearbooks for all students, thoughtfully designed to celebrate the many meaningful experiences our students share both on and off campus

SCHOOL FEES DO NOT INCLUDE

- MacBooks (required for Grades 6-12), headphones
 - Grade 12 IB and AP examination fees, DP and AP online courses (Grades 11 & 12)
 - CEESA trips, school transport, health insurance, and specific extracurricular activities
- In all cases, these costs are communicated in advance to parents.
